Web Servant – I have updated the website with this month's messenger and the current Agenda and Minutes on time this month. I will not be updating the website going forward.

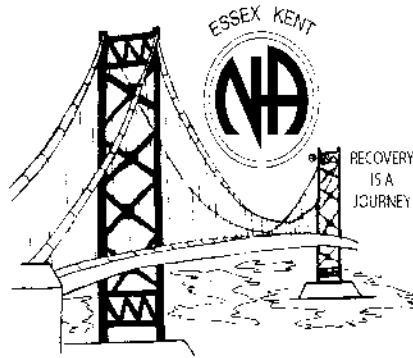
